SUBJECT: VTA Ridership for December 2019

December 2019 total monthly system ridership for bus and light rail was 2,784,032, a decrease of 4.5% over December 2018. December 2019 had one more weekday than December 2018.

Bus ridership was down by 5.3%. Light Rail ridership was down by 2.1%. December 2019 total monthly ridership recorded a 4.6% decrease compared to November 2019. Ridership change from November to December typically averages -4.0%.

The New Transit Service Plan (NTSP) went into effect on the 28th of the month. Free rides were provided on VTA's routes from December 28th through New Year's Eve to promote the plan.

In December 2019, there were two SF 49ers games at the Levi's stadium averaging 10,216 riders per event. The Historic Trolley ran for a few days in December and had to be frequently cancelled due to bad weather. The Trolley recorded a total of 284 riders for the month.

47 of the 69 Pre- NTSP bus routes, or 68%, did not meet the weekday standards as defined in the Service Design Guidelines. However, 12 of the 18 core routes, or 67%, met the weekday standards as defined in the Service Design Guidelines. It is a little too early to evaluate the newer routes based on the New Transit Service Plan in December 2019 as only 4 days in December were impacted by the Plan.

All the core routes except for Line 61 either recorded decreases or remained flat when compared to December 2018. One core route, Line 61, showed an improvement of 3.2% over December 2018 as shown in the table below:



Dear VTA Board:

Please provide guidance or enact a means for VTA passengers to lawfully transport:

- Imitation firearms such as theatrical props
- BB, pellet, paintball, and firearms
- Children's and pet toys such as a replica hand grenade

CA Penal Code 171.7(b) prohibits these items even when transported per state and federal regulations <u>if posted as</u> <u>below</u>.



BART, CalTrain, Amtrack, and many common carriers permit transporting these items. <u>Of the 23 operators listed on</u> <u>MTC's website, ONLY VTA impacts Second Amendment rights.</u> PC 171.7(b) adversely impacts:

- Youth Scouting, 4-H, and J/ROTC safety and recreational programs
- Commerce, social, recreational, and sporting activities
- Minority and low-income riders
- Handicapped persons that cannot operate or choose not to operate vehicles

The prohibition is also inimical to VTA's published strategic plan objectives to increase ridership.

Machetes, axes, and similar fixed blade implements are NOT prohibited under PC 17290 and presumably lawful to possess on VTA, yet responsible for many more fatalities or injuries than prohibited BB, pellet, or firearm rifles. I'm unable to locate any evidence that the law has benefitted passenger or employee safety. Actually, just the opposite as the policy leaves everyone defenseless.

VTA risks expensive and time-consuming consequences unless there is reasonable accommodation for passengers pursuing lawful activities. Please let me know within 30 days if and when VTA will accommodate such passengers.
