Dear VTA Board Members,

VTA just launched the BART Phase II Design Review Committee (DRC) Community Engagement period. The purpose of this engagement effort is to receive thoughtful input and recommendations on the aesthetic elements and themes for VTA's four future BART stations to be constructed as part of VTA's BART Silicon Valley Phase II Project.

Public engagement is being conducted via two methods:

- Social Pinpoint Site: VTA is inviting the community to use an interactive webpage to learn more about the project and to provide feedback on visual elements that contribute to the look and feel of the stations. This webpage is now live and feedback is welcome through mid-September 2021. The Social Pinpoint site can be accessed here: https://bit.ly/vtabsv2stations.
- Community Pop Up Events: <u>Beginning on Friday September 10<sup>th</sup></u>, <u>through September 14th</u>, project staff will be present at various community locations including farmers markets and Caltrain stations. Additional information on pop-up locations and timing can be found here: <u>VTA's BART Phase II Webpage</u>

The station survey pages included in the Social Pinpoint website contain concepts for the visual look of the station, along with options for different visual elements. Also included are station simulations that provide a virtual tour through the future stations. VTA is inviting community members to use this interactive website to learn more about the project and to provide feedback on visual elements that contribute to the look and feel of the future stations.

## **DRC Background and Process**

In June 2021, VTA initiated the first phase of station-specific BART Phase II Design Review Committees (DRCs). The purpose of the DRCs is to provide an opportunity for community and local government partners to provide input to the BART Phase II project team regarding select visual elements for each of the four stations. Such elements include types of material finishes used and areas for future art installations and/or cultural features.

Development of the initial aesthetic concepts used for this first phase of the DRCs was based on feedback received to date on the project through the environmental process, public and stakeholder meetings and workshops, and Community Working Group meetings. The DRCs for each station are comprised of leaders of local community organizations and staff from the cities of San José and Santa Clara.

Over the last three months, VTA BSV project architecture team has worked with DRC members to incorporate their thoughtful feedback and input on those initial concepts. Through this iterative process, DRC members helped further refine the aesthetic concepts, ultimately resulting in the concepts being presented during this DRC Community Engagement period.

The project team will consider and appropriately incorporate input received during the DRC Community Engagement period. This information will then be incorporated into the Phase II Project's RFP to be released in 2022.

## **Station Site Plans**

In addition, we have updated the station site plans to reflect the current design and have posted them on the project website:
