# **BACKGROUND:**

This report is routinely produced after each month. This report is for the month of January 2022.

## **CLIMATE IMPACT:**

The report is an information item and will have no impacts to climate change.

## **DISCUSSION:**

January 2022 total monthly system ridership was 1,398,908, an increase of 64.2% over January 2021. January 2022 total monthly bus ridership was 1,187,019, an increase of 76.9% over January 2021. January 2022 total monthly light rail ridership was 211,889, an increase of 17.0% over January 2021. January 2022 recorded an overall ridership increase of 1.5% over December 2021.

There was one 49ers' game at the Levi's Stadium in January 2022 that recorded about 13,100 riders.

System ridership is approximately 50% less compared to pre-pandemic levels.

## Staff Responses to A&F Committee questions regarding Paratransit Fleet Purchase

At the February 17, 2022, meeting of the Administration and Finance Committee, members posed questions regarding the item on paratransit fleet purchase. Here are the staff responses to those questions.

**1. USB for Seat Mount**: USB will be built into the seat from Freedman seat Manufacturer and vehicles will be ordered with this seat type.

**2. Air Filtration:** HEPA Filtration System will be added to purchase, the HEPA filter eliminates 99.9% of the germs / virus and pollen.

**3.** Wi/Fi System: Due to the short distance of the Paratransit trips, and not one passenger has requested that VTA add a Wi-Fi system. Most passengers are using their phones and not iPads.

**4. Charge Station for Wheelchairs:** This is not available as the conversion manufacture is unable to install the required inverter (due to the limited space in engine compartment).

**5. EMS button for driver** – this is already available to drivers through the iPad system. This provides that the driver can communicate directly to the Paratransit Dispatcher in case of an emergency.

**6. Vehicle disposal** - Since FTA funds were used, FTA process must be followed. The vehicles are auctioned, and the proceeds go into VTA's Transit Enterprise fund, where they are used for any eligible purpose, including operations.

7. Vehicles are already visible when on route, Trapeze software that is used to manage the service provides that Dispatchers can see the current location of each vehicle in service.

8. At this time there are no Paratransit EV vehicles being built and are available for sale.
