Small Business Certification Requirements

What Certification(s) should I pursue?

SBE Certification

- US Citizen (or lawfully admitted permanent residents)
- Must meet Small Business size standard prescribed by 121 CFR 13
- Size standards have been established for types of industry under the North American Industry Classification System (NAICS). Can be obtained via the Internet at www.sba.gov
- Ownership/Control
- Independent
- Race Neutral

DBE Certification

- US Citizen (or lawfully admitted permanent residents)
- Small Business size standard prescribed by 121 CFR 13
- Member of minority groups: who are women, Black Americans, Hispanic Americans, Native Americans, Asian-Pacific Americans, Subcontinent Asian Americans, or other minorities found to be disadvantaged by the SBA
- Ownership/Control
- Independent

Important Notice: Businesses registered in the System for Award Management (SAM.gov) must update their SAM registration in order to have their small business status updated based on the new size standards that became effective on August 19, 2019. Until the SAM registration is updated, the SAM profiles will continue to display the small business status under the old size standards.

WHY DO I NEED TO SUBSCRIBE?

1. Receive notices about upcoming opportunities
2. If subscribed notices are automatic
3. Bid/proposal submissions must be done electronically through the OpenGov portal **before** due date/time

Conflict of Interest

Conflict of Interest Defined

A conflict of interest occurs when an entity or individual becomes unreliable because of a clash between personal (or self-serving) interests and professional duties or responsibilities. Such a conflict occurs when a company or person has a vested interest—such as money, status, knowledge, relationships, or reputation—which puts into question whether their actions, judgment, and/or decision-making can be unbiased. When such a situation arises, the party is usually asked to remove themselves, and it is often legally required of them.

Procurement Integrity

- The general rule is to strictly avoid any conflict of interest or even the appearance of a conflict of interest in any VTA relationships
- Treat all Prospective Sources in an Equal and Equitable Manner
- Bidders cannot have an unfair advantage in obtaining a contract.

Avoid Conflicts of Interest

VTA Policy states that all VTA employees must conduct themselves in accordance with the highest ethical and professional standards

Organizational conflicts of interests can include:

- Lack of Impartiality or Impaired Objectivity
- Unequal Access to Information
- Biased Ground Rules

Conflicts of Interest and VTA Employees

1. Employee outside activities
 - a) Incompatible
 - b) Inconsistent
 - c) In conflict

2. Employees in decision making positions
 - a) Disclose financial interests

Conflicts of Interest and Contractors

NOTICE TO PROPOSERS OF LIMITATION OF FUTURE CONTRACTING

The Proposer(s) selected under this Request for Proposals (“RFP”) will be precluded from submitting proposals or bids as a prime contractor or subcontractor for any future procurement with VTA if the specifications, requirements, scope of services and/or for such work were developed or influenced by the work performed under the contract resulting from this RFP. Further, if a contractor or subcontractor obtains or has access to nonpublic information related to a future solicitation through work performed under this RFP, that contractor or subcontractor may be barred from submitting proposals as a prime contractor or subcontractor on that future solicitation.

Conflicts of Interest and Contractors

NOTICE TO PROPOSERS OF REQUIREMENT TO AVOID CONFLICTS OF INTERESTS

Contractors and subcontractors performing work resulting from this RFP are required to avoid conflicts of interest resulting from services provided to VTA through other engagements. In particular, contractors and subcontractors providing services under any engagements that developed or influenced the requirements, scope of services, or criteria for this RFP are ineligible to participate in the work resulting from this RFP. Contractors and subcontractors providing services under such engagements that involve the supervision, oversight, review, critique, or acceptance of work products under this RFP are also ineligible to participate in the work resulting from this RFP.

Conflicts of Interest and Contractors

- Similarly, contractors and subcontractors **who have** or **who have had access to nonpublic information related to this RFP** may have a conflict of interest and should refrain from participating in the work resulting from this RFP.
- Contractors and subcontractors proposing to provide services under this RFP remain responsible for avoiding conflicts of interest and must **review their existing VTA engagements with their prospective teaming partners before submitting a Proposal under this RFP** to assure that conflicts of interest are avoided. Contractors and subcontractors performing work resulting from this RFP **must continue to monitor for and avoid conflicts of interest at all times**.
- In addition to contractors' and subcontractors' obligations to avoid conflicts of interest, VTA also monitors for potential conflicts. **VTA reviews all potential conflicts, whether actual or apparent, on a case-by-case basis**. VTA reserves the right to determine whether an actual conflict exists in its sole discretion and to determine whether a potential conflict of interest exists in its reasonable discretion. Nothing in this RFP is intended to operate as a waiver of either actual or apparent conflicts.

Conflicts of Interest and Contractors

Examples

1. Construction contract with detailed specifications
2. Design firm that also performs construction drafted the specifications and intends to bid
