## **The Audit Results are In!**

The Committee commissioned an audit of the Measure A Program financial records and schedule for FY 2022 (July 1, 2021 – June 30, 2022). This is the 17th consecutive audit receiving a clean opinion.

In November 2000, Santa Clara County voters approved Measure A, a half-cent sales tax for specific public transit capital improvement projects and operations. Revenue collection began in April 2006. Highlights for FY 2022 include key activities for VTA’s BART Silicon Valley Extension project, Eastridge to BART Regional Connector project, and Caltrain Electrification efforts.
