

 - Improve traffic operations in the Project Area as well as the local street network.




Project Need

- <u>Accommodation for All Modes of Transportation</u> There are currently insufficient facilities for pedestrians and bikes
- <u>Safety</u> Bike/Pedestrian Conflict with vehicles, Short Weave between Charleston On-ramp and SB Rengstorff off-ramp
- <u>Accessibility to Local Destinations</u> Mobility to/from local destinations is currently limited
- <u>Traffic Operations</u> Lack of SB on-ramp from San Antonio Road adds to Local Street Congestion




Project Existing Conditions – Rengstorff Ave



Existing AM/PM Traffic Patterns – Rengstorff






Existing AM/PM Traffic Patterns – San Antonio






Rengstorff Ave – Bike/Ped Improvements
