- 1. Adopt a Resolution approving the appointment of Dale Austin Jenkins to the position of Interim Chief Operating Officer.
- 2. Authorize the General Manager to execute an employment contract with Dale Austin Jenkins for the position of Interim Chief Operating Officer.

BACKGROUND:

Inez Evans Benson, VTA's Chief Operating Officer will be retiring effective August 17, 2019. Pursuant to Ms. Evan Benson's notification of her intent to retire, the General Manager is seeking to appoint Dale Austin Jenkins as an Interim Chief Operating Officer concurrent with the recruitment process for the position. This appointment is necessary to continue to provide strategic leadership and day-to-day oversight to the Operations Division for an interim period while a recruitment for a permanent appointment is underway.

DISCUSSION:

Dale Austin Jenkins has been selected as an Interim Chief Operating Officer based on his well-rounded, executive operational experience for the past 40 years in the public transportation industry. Mr. Jenkins is currently the CEO of Jenkins Rail Transportation Solutions (RTS),

LLC, and provides Rail Operations consultation, design review, and other related services to his public transportation agency clients. His previous roles included: Assistant General Manager, Rail Operations with Denver Regional Transit District (2010 to December 2014); Director of Operations with Seattle Monorail Project (2003 to 2005); and was a General Superintendent with VTA from 2000 to 2004. His roles at VTA included responsibility for the daily operation of the light rail system. He also served as the Rail Activation Manager for Tasman West and the I-880 rail line extensions. Mr. Jenkins career with VTA spanned 30 years beginning as an Operator and included progressively responsible positions within the Operations Division prior to his retirement.

As a CALPERS retired annuitant, Mr. Jenkins cannot work more than 960 hours per fiscal year. The adoption of the attached resolution under Government Code section 21221(h) is recommended by CalPERS as evidence of compliance with the statutory requirements for appointments of retired annuitants in a manner that would not subject the retiree to reinstatement from retirement or loss of benefits.

ALTERNATIVES:

The Board may reject or amend the terms of the contract. Any amendments would be subject to agreement by Mr. Jenkins.

FISCAL IMPACT:

This action will authorize \$110.58/hour for up to 960 hours. Appropriation for the value of this contract is included in the adopted FY 2019 and FY 2020 VTA Transit Fund Operating Budget.
